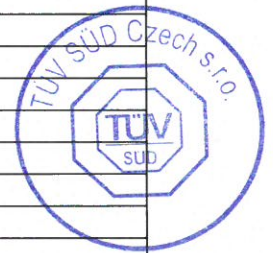

Description:		
The trampolines are designed for year-round use. They may be used as a single section or alternatively expanded and thereby forming trampoline assembly or some trampoline arena. For anchoring to ground is used a special anchoring products. The construction of the trampoline is made of stainless steel. The trampoline springs are covered by construction of trampoline. Jumping area is made up of cubes from PA6 or PE300 which are connected by a steel rope. To protect against injuries (around the jumping area) are used strips (min. 25 cm) of hygiene granulates EPDM/SBR which are glued with a special adhesive.
